## Outcomes: Meeting held on 8 June 2021

#### **Elections**

As members are aware, the PSA BOD held a virtual meeting with members on 8 June 2021, after having met with the Branch executive. During the virtual meeting the following was communicated to the membership:

- That the previous round of elections held in March 2021, have been declared null and void because
  the ballot paper utilised for the exercise was defective in that it prompted parties on who to vote into
  certain positions within the Branch executive.
- That in as far as the Branch management in the Department is concerned, the *status quo* would remain (as set out in Circular 9 of 2020- *attached*). This means that the Chairperson would remain Ms Nomabandla Silinyana, the Secretary of the Branch would remain Ms Dimakatso Mokwadi, and the two other members of the executive who would remain Morangwa Ramonyathi and Dakalo Masia.
- Dakalo Masia remains a duly appointed shop steward in the structure after a verification process done
  by the Administration after concerns were raised about his position.
- The current Branch executive has been tasked with ensuring that elections take place at the DOT to elect a new Branch executive. This will be done in collaboration with the Pretoria Provincial Office.
- The date and details of the elections will be communicated to members as soon as these have been finalised.
- · Members are reminded that a united PSA is beneficial to all members.
